CLC TOUR OF THE MILITARY VEHICLE TECHNOLOGY FOUNDATION

Location: Meet at Woodside Plaza shopping center, corner of Massachusetts and Woodside Rd (hiway 84) in Redwood City. There is a coffee shop in the plaza or coffee available at the Lucky Market. Park in the lot near the Wells Fargo Bank. We will be traveling a few miles south on 280 to Alpine Rd in Portola Valley, total driving distance about 10 miles.

We're going to have a guided tour of the Foundation buildings, formerly known as the Littlefield Collection. The buildings are full of restored tanks, artillery, amphibious vehicles, missile launchers, and many other military vehicles. Mr. Littlefield passed away over a year ago and the collection is now a historic foundation. The tour will take about two hours and we will stop for lunch after the tour at the Alpine Inn in Portola Valley, well known in the area for it's burgers, beer, and large outdoor patio.



Cadillac & LaSalle Club Museum and Research Center Update



The rendering above shows the building design concept of the new Cadillac Museum that has been approved by the CLCMRC Board of Directors and the Gilmore Advisory Committee. As soon as the Gilmore Board of Trustees approves this design concept (scheduled for late February), design of the actual building details will begin.

The CLCMRC (Cadillac-LaSalle Club Museum and Research Center) Board held their winter meeting in Quincy, MA on Friday, January 14, 2011. Like the CLC Board the Museum Board overcame the winter elements and travel hurdles to meet in the Boston area in January!

The two main topics of focus for the board meeting were the status of the building design proposal as well as the status of the fund raising campaign.

The Gilmore is establishing the future look and direction for the museum campus expansion and therefore it has been a slower and more arduous process than anticipated. The Gilmore Advisory Committee has agreed on a design (see rendering above) and will recommend its approval at the February meeting of the Gilmore Museum Board. It is a 1940's / 50's rendering from the 1948 General Motors Planning Automobile Dealer Properties publication. Once approved communication of the final design will be forthcoming.

The "Celebrating the Standard" fund raising campaign is progressing nicely. Early in the campaign with approximately 2% of the membership and some Region treasuries already having pledged, over one-eighth of the goal has been reached. That is quite an encouraging start and gives an indication that our goal is reachable.

BELOW IS SOME SIGNIFICANT INFORMATION IN MAKING A TAX-ADVANTAGED GIFT TO A CHARITY TAX RELIEF ACT EXTENDS IRA OWNERS' OPPORTUNITY TO MAKE TAX-ADVANTAGED DIRECT GIFTS TO CHARITY

If you have an individual retirement account (IRA) and have reached age 70-1/2, the Tax Relief Act passed in December provides you with a special tax-advantaged way to support CLCMRC. A tax incentive that previously expired at the end of 2009 is now extended through the end of this year.

In general terms, an IRA account owner who is at least 70-1/2 years old may distribute up to \$100,000 per year by direct gift from his or her IRA to a qualifying charity. The benefit is that this direct gift will not be included in the donor's income for tax purposes, but will count toward satisfying his or her minimum required distribution (the amount that must be withdrawn from one's IRA each year to avoid penalty).

If the direct gift is made by January 31, 2011, the donor may elect to treat it as made in 2010, which has two potential advantages: (1) it can count toward satisfying his or her minimum required distribution for 2010, and (2) it permits him or her to make a second contribution up to \$100,000 for 2011. If a husband and wife have separate IRAs, each one may make a direct gift up to this limit.

Generally the direct gift must be made from a traditional IRA, not a qualified plan or a 403(b) plan. (In unusual circumstances, it may be possible to use a Roth IRA, but you would need to contact your tax adviser about this.)

Only certain charities qualify to receive direct gifts. CLCMRC does qualify, but direct gifts may not be made to donor advised funds, most private foundations, and "supporting organizations". And, of course, the correct procedure must be followed -- the payment must be made by the IRA trustee directly to the charity.

This technique offers significant advantages over withdrawing funds from one's IRA and donating them to charity. While at first glance the income and deduction may appear to be a "wash", it isn't necessarily so. Some taxpayers use the standard deduction, and do not itemize. Some taxpayers who itemize receive only limited tax benefits from their itemized deductions. Others may lose tax benefits by taking the IRA withdrawal into income, even if they turn around and give it to charity. The technical rules go beyond what we can discuss here, but your tax adviser will be able to explain.
